WHEREAS, Education Law Section 1724(3) authorizes the board of education of a union free school district, by resolution, to authorize the payment in advance of audit of claims for public utility services, postage, freight and express charges, provided all such claims shall be presented at the next regular meeting for audit (or in lieu thereof, approved by the District Claims Auditor), and provided further that the claimant and the officer incurring or approving the same shall be jointly and severally liable for any amount disallowed by the board of education; and</p> <p>WHEREAS, as used in the said Section 1724(3), the term "public utility services" means electric, gas, water, sewer and telephone services; and</p> <p>WHEREAS the District regularly incurs charges for postage, freight, express, and public utility services as defined in Education Law Section 1724(3); and</p> <p>WHEREAS such charges are incurred in the regular course of business of the District and are necessary to its operation; and</p> <p>WHEREAS such charges must be paid in a prompt manner to avoid disruption of these needed services and to receive discounts for prompt payment; and</p> <p>WHEREAS, the Board of Education has determined that it is in the best interest of the district to authorize the payment of claims for charges for public utility services, postage, freight and express charges in accordance with the provisions of Education Law Section 1724(3); now therefore be it</p> <p>RESOLVED, that pursuant to the authority granted by Education Law Section 1724(3), the Assistant Superintendent for Business and/or Purchasing Agent be and are hereby authorized to review and approve any voucher for claims for public utility services, postage, freight and express charges in advance of audit; and be it further</p> <p>RESOLVED, that the Assistant Superintendent for Business and/or Purchasing Agent may require the District employee incurring or approving such claim and/or claimant to supply any additional information necessary to determine the validity and necessity of such charge reflected in the voucher; and be it further</p> <p>RESOLVED, that pursuant to the authority granted by Education Law Section 1724(3), the Board of Education hereby authorizes the Assistant Superintendent for Business and/or Purchasing Agent to pay any claim for public utility services, postage, freight and express charges in advance of audit; and be it further</p>	<p><b>New Business</b></p> <p><b>Approval of authorization of board of education free school district to authorize payment in advance of audit of claims</b></p>
